## LA DOCUMENTACION COLONIAL EN LA LUISIANA

La ocasión del bi-centenario de la fundación del Archivo General de Indias es momento muy digno para recopilar la documentación original que queda en el actual estado de la Luisiana de su época como colonia Francesa (1699-1763) y Española (1763-1803). La mayor parte de tal documentación es de la época española, hecho que es testimonio del florecimiento de la colonia bajo el mando español. Pero por falta de un inventario general, hasta ahora esta riqueza documental ha sido mucho menos conocida por los investigadores que los fondos del Archivo General de Indias (Papeles Procedentes de Cuba (PC) y Santo Domingo) o del Archive National de Francia. El inventario que sigue, por ser primero de su clase, es ofrecido como homenaje al Archivo General de Indias y como invitación a los investigadores a utilizar la documentación descrita.

El investigador que quiera obtener una orientación de las bibliotecas y colecciones que tienen estos documentos debe consultar los artículos siguientes que pueden servir como guías de investigador:

## DOCUMENTACION ORIGINAL

### I. Judicial Records / Pleitos, Sucesiones, etc.

Tal vez el fondo documental más importante que queda en el estado, la documentación judicial del antiguo *Conseil Superior* de los Franceses y del juzgado del Gobernador Español está en el Louisiana Historical Center. Hay unos 500.000 folios, todos microfilmados después de ser limpiados y conservados en los años 70 del presente siglo. Lástima, no hay índice ni calendario completo y moderno de esta documentación. Hay varios calendarios del principio del siglo presente que pueden servir para dar una idea de la riqueza de estos documentos para la historia social y económica de la colonia.

A. French Superior Council Judicial Records, 1714-1769. Approximately 200.000 folios. Documents recorded with the Superior Council, serving as official recorder, and from lawsuits, sucesiones, and similar

matters adjudicated before the Superior Council sitting as a court. At some point, many of the original cases were separated into individual documents. CALENDAR: to 1727, LHC, prepared in 1970s; still useable but superceded for the period covered by the LHC calendar: H. H. Cruzat and G. Lugano, "Records of the Superior Council of Louisiana", *Louisiana Historical Quarterly*, I-XXV (1917-43), *passim*. MICROFILM: GS, LHC; 77 Rolls at TU (old film, of poorer quality than the Genealogical Society film).

B. Spanish Judicial Records, 1769-1803. Approximately, 300.000 folios. Lawsuits over debts, successions, similar civil matters. PARTIAL CALENDAR: 1769 to 1793, LHC, prepared in the 1970s; still useable: Laura L. Porteus, "Calendar of Spanish Judicial Records, to August 9, 1785", *Louisiana Historical Quarterly*, VI-XXXI (1923-49), *passim*. MICROFILM: GS, LHC.

See also the so-called "black books", a series of loose-leaf notebooks prepared in the 1920s and 30s with summaries of each document or case in these records. These "black books" are held by the Louisiana Historical Center. Another tool is Thelma C. James, "Index to French and Spanish Translations of Original Documents" (Louisiana State Museum Library), *New Orleans Genesis*, I-VIII (1962-70), *passim*, which is little more than a listing from the "black books" of the parties and the type of document.

## II. Notarial Records / Archivos de Protocolos

En la época colonial los comandantes de los "posts" fueron a veces escribanos públicos, faltando tal oficial, como fue casi normal. Sea quien sea el escribano, la documentación de esta clase es tan variada e importante como en todos los archivos de protocolos. La mayor parte es documentación de venta y compra de tierras, esclavos, y cosechas. Otra parte consiste en dotes y asientos matrimoniales. La conservación de los fondos es buena en general aunque varios investigadores denuncian la pérdida progresiva de documentos de interés genealógico, por ejemplo en Avoyelles Parish.

Al llegar la administración Americana, los "posts" se convirtieron en "condados" del tipo Ingles/Americano pero con el nombre "Parishes" o parroquias, nombre que significa que el distrito de cada "parish" fue entonces equivalente a parroquia eclesiástica. Desde entonces los "Clerk of Court" de los nuevos condados sirven como archivos de la documentación legal y notarial de los antiguos comandantes y escribanos de los

Posts. Pasando los años, las parroquias primitivas se dividieron y a veces también la documentación colonial. Por ejemplo, el distrito del Attakapas Post hoy incluye las "parishes" de St. Martin, St. Mary, Lafayette, Vermillion, y Iberia. Los Clerk of Court de St. Martin y Lafayette Parishes custodian documentación del distrito del antiguo Post de Attakapas, con la mayoría de ella en St. Martin Parish. Los casos de Nueva Orleans y la provincia de la Florida Occidental (1803-1810) son algo diferentes de esta historia pero no muestran dificultad en el manejo de su documentación colonial. Los nombres de Attakapas y Opelousas se perdieron; hoy la documentación de estos Posts queda en manos del Clerk of Court de St. Martin Parish y del Louisiana State Archives and Records Service.

Para manejar esta documentación hay varios índices y calendarios con resúmenes (en general en Inglés). Se publicaron muchos de estos últimos y algunos otros están previstos. Los trabajos del Geneological Society of the Church of Jesus Christ of Latter Day Saints (Mormons) también aportan índices de interés y valor aunque limitados a datos genealógicos. Guía general no la hay además de este inventario presente, que se fundó en el Works Progress Administration (WPA), *Inventories* de los años 30 del siglo presente y unos informes preparados a instigación del Louisiana State Archives en los años 1976-77.

La mayoría de los archivos de protocolos de interés se microfilmaron por el Geneological Society, al menos en parte. En otros casos los Clerks of Court que custodian los documentos los microfilmaron hace tiempo.

### III. Official Surveys / Deslindes de Tierras

Siguiendo las ordenanzas de Alejandro O'Reilly de 1769 y del Baron de Carondelet de 1799, el agrimensor general de la provincia tuvo que medir y recordar todas las concesiones de tierras autorizados por el gobierno. Un registro oficial de estos deslindes se formó antes de 1778 cuando ocurrió el incendio general de Nueva Orleans. Perdido entonces, fue reconstruido con documentación del despacho del Gobernador; pero otra vez fue perdido en el incendio de 1794 aunque en este caso se salvaron uno de los borradores de los deslindes guardados en el despacho del agrimensor general, D. Carlos Laveau Trudeau. Trudeau lo tuvo hasta 1805 cuando decidió quedarse en la Luisiana. Entonces, le entregó a su teniente, Vicente Sebastián Pintado, que lo llevó a Pensacola donde renunció al oficio de agrimensor general de la Florida Occidental. Después de 1816, Pintado fue a Cuba, donde murió. En circunstancias mal conocidas, los registros pasaron después a Luisiana y antes de 1870 a Louisiana State University.

Otra historia tienen los borradores y copias de deslindes que quedaron en manos de Trudeau. Su viuda los vendió al estado de Luisiana en 1817 y quedan en el "General Land Office" hasta los años 1880, al parecer. Después desaparecieron de tal despacho y pasaron a manos particulares. Por los años 20 del siglo presente se vendieron en grupos a bibliotecas y personas con interés por documentación vieja. En 1983, con ocasión de la venta anticipada de unos 270 documentos de la colección del Western Reserve Historical Society, de Cleveland, Ohio, el estado inició demanda reclamando su propiedad, al parecer robado un siglo antes. Al presente no se sabe dónde están todos los documentos de la antigua colección de Trudeau pero poco a poco se van descubriendo.
